



## Privacy Notice Pupils

### Privacy Notice - How we use pupil information

We collect and hold personal information relating to our pupils and may also receive information about them from their previous school. Our school uses and processes pupil information within the remit of the Regulation (EU) 2016/679 (General Data Protection Regulation), referred to throughout this statement as the GDPR.

The categories of pupil information that we collect, hold and share include:

- Personal information (such as name, unique pupil number and address);
- Characteristics (such as ethnicity, language, nationality, country of birth and free school meal eligibility);
- Attendance information (such as sessions attended, number of absences and absence reasons);
- Assessment information (such as internal tests, pupils progress information and examination results);
- Medical information (such as allergies to food, medication a student may require and medical incidents that have occurred inside or outside of school that may affect learning);
- Special Educational Needs and Disabilities information (such as specific learning difficulties, specific medical needs and previous learning or medical needs);
- Information regarding behaviour (such as achievements, sanctions and exclusions); and
- Safeguarding information (such as Early Help Assessments, Team Around the Child paperwork and child protection referrals).

We also process special categories of personal data that may include:

- physical or mental health needs;
- racial or ethnic origin;
- religious or other beliefs of a similar nature.

### Why we collect and use this information

We use the pupil data:

- to support pupil learning;
- to monitor and report on pupil progress;
- to provide appropriate care and guidance;  to assess the quality of our services; and  to comply with the law regarding data sharing.

### The lawful basis on which we use this information

We collect and use pupil information under Article 6 and Article 9 of the GDPR, this enables our school to process information such as assessments, special educational needs requests, Departmental Censuses under the Education Act 1996 and the Education Act 2005, examination results and other such data processes that relate educational data to the individual within the requirements for the school to provide education for the individual.

### Collecting pupil information

Whilst the majority of pupil information you provide to us is mandatory, some of it is provided to us on a voluntary basis. In order to comply with the General Data Protection Regulation, we will inform you whether you are required to provide certain pupil information to us or if you have a choice in this.

### How do we collect your personal data?

Information may be collected in many different ways but predominantly as set out below:

- face to face - if you attend our school or we visit you we may collect your personal data;
- letters and forms – we may request permission or information to support your child in their education;
- telephone calls – we may record the content of the conversation;
- emails - if you email us we may keep a record of your email address and the email as evidence of the contact.
- CCTV - we have installed CCTV systems on our premises, for the purposes of public, pupil and staff safety and crime prevention and detection. Signs are displayed notifying you that CCTV is in operation and providing details of who to contact for further information. We will only disclose CCTV images to others who intend to use the images for the purposes stated above. CCTV images will not be released to the media for entertainment purposes or placed on the internet. Images captured by CCTV will not be kept for longer than necessary, as per our Data Retention policy.

### Storing pupil data

We hold pupil data in line with our Data Retention Guidelines, which are available upon request.

Who we share pupil information with We routinely share pupil information with:

- schools and other educational environments that the pupils attend after leaving us;  our local authority;
- the Department for Education (DfE);
- the police and law enforcement;
- the Lincolnshire Community Health Service; and  the National Health Service.

### Why we share pupil information

We do not share information about our pupils with anyone without consent unless the law and our policies allow us to do so.

We share pupils' data with the Department for Education (DfE) on a statutory basis. This data sharing underpins school funding and educational attainment policy and monitoring.

We are required to share information about our pupils with the (DfE) under regulation 5 of The Education (Information About Individual Pupils) (England) Regulations 2013.

### Data collection requirements

### The National Pupil Database (NPD)

The NPD is owned and managed by the Department for Education and contains information about pupils in schools in England. It provides invaluable evidence on educational performance to inform independent

research, as well as studies commissioned by the Department. It is held in electronic format for statistical purposes. This information is securely collected from a range of sources including schools, local authorities and awarding bodies.

We are required by law, to provide information about our pupils to the DfE as part of statutory data collections such as the school census and early years' census. Some of this information is then stored in the NPD. The law that allows this is the Education (Information About Individual Pupils) (England) Regulations 2013.

The Department may share information about our pupils from the NPD with third parties who promote the education or well-being of children in England by:

- conducting research or analysis;
- producing statistics; and/or
- providing information, advice or guidance.

The Department has robust processes in place to ensure the confidentiality of our data is maintained and there are stringent controls in place regarding access and use of the data. Decisions on whether DfE releases data to third parties are subject to a strict approval process and based on a detailed assessment of:

- who is requesting the data
- the purpose for which it is required
- the level and sensitivity of data requested: and
- the arrangements in place to store and handle the data.

To be granted access to pupil information, organisations must comply with strict terms and conditions covering the confidentiality and handling of the data, security arrangements and retention and use of the data.

#### Requesting access to your personal data

Under data protection legislation, parents/carers and pupils have the right to request access to information about them that we hold. To make a request for your personal information, or be given access to your child's educational record, contact Katie Grivil, Headteacher.

You also have the right to:

- object to processing of personal data that is likely to cause, or is causing, damage or distress;
- prevent processing for the purpose of direct marketing;
- object to decisions being taken by automated means;
- in certain circumstances, have inaccurate personal data rectified, blocked, erased or destroyed; and
- claim compensation for damages caused by a breach of the Data Protection regulations.
